RE: NEW SUNSET ECONOMIC DEVELOPMENT DISTRICT

On May 13, 2021, the Board of Aldermen of the Town of Sunset adopted Ordinance No. 2 of 2021, creating a new Economic Development District within the Town of Sunset. This District will be called the Sunset EDD. All taxable transactions in this area will require an additional 2% sales/use tax to be collected. This new tax will affect all businesses, deliveries, repairs and other taxable services that are performed in this area.

The current local rate for this area is 5.55% and will increase to 7.55%. The vendor's compensation will remain the same at (1.1%). The penalty and interest collected on delinquent taxes will also remain the same: penalty (5%) per month not to exceed (25%) and interest (15%) per annum or (1.25%) per month.

Please make the proper changes in order to begin collecting this new tax rate on **October 1**, **2021**. Taxpayers will not begin remitting this tax to our Department until November 1, 2021. The tax for this District will be reported in column **I1 – 7.55% (SUNSET EDD)**.
