TO: ALL DEALERS ENGAGED IN BUSINESS WITHIN IBERIA PARISH

SUBJECT: SALES AND USE TAX RATE INCREASES EFFECTIVE JULY 1, 2024 AS FOLLOWS:

IBERIA PARISH GOVERNMENT - 3/4 CENT TAX (rural areas of the parish-Columns E & F only)

IBERIA PARISH SHERIFF'S DEPT - ¼ CENT TAX (parish wide tax, effective in all 10 columns)

As a result of voter approval on April 27th, the residents of Iberia Parish have passed **two** new sales taxes upon the sale at retail, the use, the lease or rental, the consumption and the storage for use or consumption of tangible personal property and the sales of services in said Iberia Parish all as presently defined in R.S. 47:301 thru 47:317 and R.S. 47:337.1 thru 47:337.102 inclusive.

The additional ¾ cent tax, effective July 1, 2024 will be applicable **only** on transactions occurring in the rural areas of Iberia Parish. This tax is **not** applicable within any of the incorporated municipalities of Iberia Parish. This tax is only applicable in Column E and Column F (it is not applicable in any of the other eight columns on the Iberia Parish sales tax return).

The ¼ cent tax for the Sheriff, also effective July 1, 2024 will be applicable parish wide and it will be applicable in all ten columns on the Iberia Parish sales tax return.

Columns A,B,C,D,G,K,L and M will all increase by ¼ cent and Columns E and F will increase by one cent (¾ cent plus ¼ cent).

Therefore, the new sales tax rates for each column will be as follows:

Column A: from 5.00% to 5.25% Column B: from 4.50% to 4.75%

Column C: from 4.75% to 5.00% Column D: from 4.25% to 4.50%

Column E: from 3.25% to 3.50% to 4.25% (There will be two increases in Column E, ¼ cent plus ¾ cent)

Column F: from 4.25% to 4.50% to 5.25% (There will be two increases in Column F, 1/4 cent plus 3/4 cent)

Column G: from 5.25% to 5.50% Column K: from 5.75% to 6.00%

Column L: from 5.75% to 6.00% Column M: from 5.50% to 5.75%
