Important Changes to Local Sales Tax in Caddo Parish

Effective July 1, 2025

The Caddo Parish Commission acting as governing authority of the I-49 North Corridor Economic Development District (District) approved a resolution establishing a 2% sales tax within the boundaries of the District at the Rocking R. Travel Plaza located in the corporate limits of the Village of Hosston, Louisiana.

A Resolution Establishing a sales tax within the boundaries of the I-49 North Corridor Economic Development District in connection with the Pilot Agreement with Edgemont Holdings, LLC and otherwise providing with respect thereto...

NOW, THEREFORE, BE IT RESOLVED, by the Caddo Parish Commission acting as the governing authority of the I-49 NORTH CORRIDOR ECONOMIC DEVELOPMENT DISTRICT in due, regular and legal session convened, that the Caddo Parish Commission, acting as the governing authority of the I-49 NORTH CORRIDOR ECONOMIC DEVELOPMENT DISTRICT, does hereby authorize the levy and collection of a two cent sales and use tax upon the sale at retail, the use, the lease or rental, the consumption and storage for use or consumption, of tangible personal property and any other property which may be subject to sales and use tax in the State of Louisiana now or in the future and on sales of services in the District for a period commencing on May 1, 2025 and ending on May 31, 2032, all in the manner and subject to the provisions and terms of those portions of Title 47 of the Louisiana Revised Statutes of 1950, as amended, applicable to sales and use taxes levied by the District for the purposes of funding construction of, acquisition of, and upgrades to capital improvement and economic development projects within the District's boundaries and any and all authorized purposes under the applicable provisions of Part II, Chapter 27, Title 33 of the Louisiana Revised Statutes of 1950, as amended (La. R.S. 33:9038.31, et seq.).
