Payments postmarked between November 9<sup>th</sup> and November 19<sup>th</sup> is subject to the late registration fee. Payment and mailing instructions are on the forms.

In an effort to effectively plan for attendance at the various conference activities and kits, <u>THERE WILL BE NO</u> <u>ON-SITE REGISTRATION OR PAYMENTS ACCEPTED AFTER THE NOVEMBER 19<sup>TH</sup> DEADLINE</u>. Conference check-in will begin at 8:00 AM on Wednesday December 8<sup>th</sup> and continue through Friday December 10<sup>th</sup>.

## HOTEL RESERVATIONS

Hotel reservations can be made via the web by <u>clicking here</u> or calling (888) 696-4806. Be sure to use the code "**LATA**" to take advantage of the discounted rate of \$99.00 per night. All major credit cards are accepted. Please have your LA government hotel exemption form prepared to exempt payment of the 4% state tax. We are responsible for the payment of the City of New Orleans local taxes of 9% and the occupancy tax of \$2.00 per night as there is no exemption form for these local taxes.

Parking is by valet in a separate garage from the hotel and is \$20.00 per day plus tax. I strongly suggest carpooling if several of you are traveling from the same office or area to minimize this cost.

Complimentary hi-speed internet access is available in the business center and wireless internet throughout the lobby and public spaces in hotel.

**<u>Reservations must be made by Monday, November 8, 2010</u>** to assure the rate offered. If you need to cancel your reservation, you must do so seventy-two (72) hours prior to the day of your planned arrival. Non-cancelled rooms will not be refunded as per the hotel policy.
