PROCES VERBAL OF THE CANVASS OF THE VOTES CAST AT THE SPECIAL ELECTION HELD IN THE PARISH OF ST. MARY, STATE OF LOUISIANA, ON SATURDAY, MAY 2, 1987.

BE IT KNOWN AND REMEMBERED that on Wednesday, May 13, 1987, at four-thirty (4:30) o'clock p.m., at its regular meeting place, the Parish Council Room of the Courthouse, Franklin, Louisiana, the Parish Council of the Parish of St. Mary, State of Louisiana, acting as the governing authority of the Parish of St. Mary, State of Louisiana (the "Parish"), and being the authority ordering the special election held therein on Saturday, May 2, 1987, with the following members present:

did, in public session, examine the official certified tabulations of votes cast at the said election, and did examine and canvass the returns of the said election, there having been submitted at said election the following proposition, to-wit:

PROPOSITION

Shall the St. Mary Parish Council, the governing authority of the Parish of St. Mary, State of Louisiana, be authorized to levy and collect the existing 3/4% sales and use tax (the "Tax") (approved at an election held in said Parish on December 11, 1973) for an additional ten (10) years from and after January 1, 1999 (the present expiration date for the Tax), with the avails or proceeds of the Tax to be (1) allocated, distributed and used for those purposes and be subject to funding into bonds by the respective recipients of the Tax, as set forth in the proposition approved at the election held in St. Mary Parish on December 11, 1973; and (2) then be dedicated and used and bonds issued by the political subdivisions among which the Tax is allocated for the following additional purposes, viz:

St. Mary Parish Council: Constructing, acquiring, improving, maintaining and operating fire protection facilities.

Municipalities: Constructing, acquiring, improving, maintaining and operating fire protection and police protection facilities.

all in accordance with the provisions of Article VI, Section 29 of the Constitution of the State of Louisiana of 1974, R.S. 33:2721.1 and 2721.6, Sub-Part F, Part III, Chapter 4, Title 39 of the Louisiana Revised Statutes of 1950, as amended, and other constitutional and statutory authority supplemental thereto?
